Edward Loedding tells The Rickie Report, "I call my technique Visual Choreography because it brings many elements together to create a dance for your eyes. The process blends photo montage, digital painting, and a unique printing process that utilizes 12 colors of 100% pigment ink. I have been creating art this way for approximately 15 years, after more than 20 years as an oil painter".

He says, "My transition from painting in oils to painting digitally was a search for a more fluid way to create artwork: a way to change lines and shapes and colors throughout the process as the piece evolved. Along the way, I discovered that this medium offered so much more. It was a way to execute my vision in real time as it unfolded; it was creating at the speed of thought".
